If Passport is expired for less than 6 Months – self- explanation notarized letter is required explaining "Why the passport was not renewed on time".

2 Lost, Damaged or Passport expired for more than 6 Months:

Notarized Affidavit of Lost, Damaged or Passport Expired more than Six Months.

(Total 7 Copies of Nationality Verification Form are required)

If passport is Damaged;

• Question No 26 of Online Application must be notarized

If passport is lost:

- Original Detailed Police Report
- Question No 26 of Online Application must be notarized

For Chicago Jurisdiction: Passport expired for more than 2 to 3 Years: 2 witness documents are required such Notarized photocopy of passport and legal status is required with the letter stating that they know the applicant for more than 5 years.

For Houston Jurisdiction:

- If passport is Lost, Damaged or Expired for more than 3 years applicant would be required to submit "4 Point Affidavit".
- If Passport expire for more than 6 months <u>self-explanation notarized letter</u> is required explaining "Why the passport was not renewed on time".

3 Spouse name need to be endorsed, if married:

- Notarized photocopy of marriage certificate
- Notarized photocopy of valid spouse passport 1st & last page only (If US Citizen by birth then copy of their ID card or US passport is required.

4 For Minor applicant below 18 years:

The below documents are mandatory in case of applying for minor

- Notarized valid passport copies of both parents (First and Last pages)
- Notarized photocopies of the valid visa status of both parents.
- Question No 28 of Online Application Form: Need to be signed by both parents and

notarized.

- Notarized Change in Appearance Affidavit.
- Notarized affidavit for minor child

If one of the parent is in India or abroad, the above mentioned documents to be attested by Regional Passport Officer only.

For parents divorced or separated

- Notarized photocopy of court decision with custody confirmation.
- Affidavit for a passport of a minor child by parents who are separated but not formally divorced or Single parent born out of wedlock

For one of the parents is deceased

• If one of the parents is deceased a notarized photocopy of death certificate is required.

For new born child

• Notarized Birth certificate and Registration of birth from local consulate.

5 Addition or deletion of spouse's name after marriage:

Addition of spouse's name:

- Notarized Affidavit for Change in Name after Marriage
- Notarized photocopy of marriage certificate
- Notarized photocopy of spouse's passport 1st & last page only (If US Citizen by birth then copy of their ID card or US passport is required.

Deletion of spouse's name after divorce or death

• Notarized copy of "Divorce Decree/ Death Certificate is required whichever is applicable.

6 For Change of Date of Birth and Place of Birth

- Court order issued by a judicial officer of 1st Class Magistrate in India and Competent Authority issues an amendment or correction in the date and place of birth of the applicant.
- Notarized Birth Certificate or school leaving certificate and passport copy having correct spelling of parents name.

7 For Change of Name or Split Name

- Advertisement in two daily Newspapers: One in USA and India (Require original full page newspaper and apply after waiting for 1 month of releasing of advertisement)
 - Court order issued in India or USA for change of name
 - Notarized Deed poll sworn Affidavit

8 Spelling correction of parents name

- Notarized parent's passport copy having correct spelling of parent's name.
- Notarized school leaving certificate.
- Notarized Birth Certificate

9 Affidavit for No status

 You would be required to submit No Status affidavit if you status is pending or approved with USCIS. Notarized affidavit of No status with notarized photocopies of the valid Indian passport and the valid green card (front and back) of two witness.

Sorting Order

Paste all photographs wherever applicable

All documents need to be A4 or 8* X 11* inches

All documents must be printed one sided (no back to back pages)

Keep all the documents in one envelope i.e. photographs, Money order etc.
